• CI 301, CI 302, CI 316, CI 324, CI 325, CI 415, CI 461, CI 493

Students transferring into the Bachelor of Applied Science (B.A.S) online only program can anticipate completing additional required lower-level A.A.S courses during their B.A.S degree pursuits. Students can substitute online upper-level elective courses to complete those lower-level requirements.

Students transferring to West Virginia University with an Associate of Arts or Associate of Science degree will have satisfied the General Education Foundation requirements at WVU. However, for this pathway, students will need to complete any outstanding GEF course during their B.A.S pursuits. Students should work with their advisor to ensure all requirements are complete.
