- MTH 225 = STAT 211. This is acceptable for the STAT 111 requirement.

Although it is the most pursued option, students may forgo this summer session and complete the requirement via study abroad or thesis composition. Students are encouraged to work with their advisor to select the option that best suits their academic needs and interests.
