
For this agreement, the following course substitutions are being allowed:

- CS 1TC = BCOR 121 + BCOR 1TC. This is acceptable for AGEE 110 requirement.
- ECN 202 = ECON 201. This is acceptable for ARE 150 requirements.
- ACC 121 = ACCT 1TC. This is acceptable for the ARE 110 AOE requirement.
- MKT 260 = BTEC 104. This is acceptable for the ARE 204 requirement.
- BUS 206 = BTEC 212. This is acceptable for ARE 482 or as a restricted elective.

Students transferring to West Virginia University with an Associate of Arts, Associates of Applied Science or Associate of Science degree will have satisfied the General Education Foundation requirements at WVU.
