Although not directly equivalent the John Chambers College of Business and Economics courses the following will be utilized via substitutions:

- ACCT 101 = ACCT 1TC for ACCT 201
- ACCT 102 = ACCT 1TC for ACCT 202
- CMIS 101= CS 1TC for BCOR 121.

To be admitted to the Chambers College of Business and Economics, students must have an overall 2.25 GPA. Students must also complete the following College of Business and Economics prerequisite courses with a minimum grade of C- or better:

- ACCT 101 & ACCT 102
- ECON 200 & ECON 202
- ENGL 101 & ENGL 102
- MATH 145 & MATH 120/A or MATH 125
- CMIS 101

Students completing the above articulated plan of study may choose to enroll in any of the following Chambers College of Business and Economics programs: Accounting; Economics; Entrepreneurship & Innovation; Finance; General Business; Global Supply Chain Management; Hospitality and Tourism Management; Management; Management Information Systems; Marketing; Organizational Leadership.

*Students need to complete MATH 145 (WVU's MATH 126) for admission to the Chambers College of Business and Economics. Students will only need to complete MATH 175 (or MATH 150 at WVU) with a C- if pursuing one of these majors: Economics, Finance, Global Supply Chain Management, and Management Information Systems.

Additional criteria for admissions must also be met for specific programs, see below course or equivalent course requirements:

- Accounting: A grade of B- or higher in ACCT 101 & ACCT 102; A minimum grade of C- in MATH 145.
- Economics: One B- or higher, and one C- or higher in ECON 200 & ECON 202; A minimum grade of C- in MATH 175 or MATH 150 at WVU.
- Entrepreneurship and Innovation: minimum grade of C- in MATH 145.
- Finance: A grade of B- or higher in ECON 200 & ECON 202; A minimum grade of C- in MATH 175 or MATH 150 at WVU.
- General Business: minimum grade of C- in MATH 145.
- Global Supply Chain Management: A minimum grade of C- in B MATH 175 or MATH 150 at WVU.
- Hospitality and Tourism Management: Minimum grade of C- in MATH 145.
- Management: minimum grade of C- in MATH 145.
- Management Information System: minimum grade of C- in MATH 175 or MATH 150 at WVU.
- Marketing: minimum grade of C- in MATH 145.
- Organizational Leadership: minimum grade of C- in MATH 145.

Students transferring to West Virginia University with an Associate of Arts or Associate of Science degree will have satisfied the General Education Foundation requirements at WVU.
