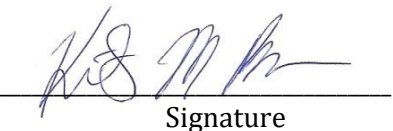

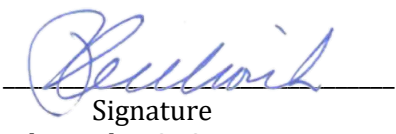
ACCT 202 (WVU's ACCT 202) has been approved to be utilized as a Restricted Elective.
