- ACCT 1TC – ARE 110 (AoE)

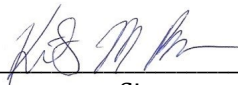
ACCT 1212 (WVU's ACCT 1TC) has been approved to be utilized as a Restricted Elective.

Students are encouraged to work with their advisor to select the option that best suits their academic needs and interests.
