The above plan of study provides students with the opportunity to complete both their Bachelor of Arts in Psychology, and a minor in Addiction Studies from West Virginia University.

Courses marked * can be completed by taking equivalents at Garrett College.

Unlike the other articulated plan of study to the WVU Psychology major, which are Associate of Arts degrees, this is an Associate of Applied Science. AAS degrees do not satisfy the General Education Foundation requirements at WVU as AA or AS degrees do. Therefore, as indicated in the final two years curriculum, students should work with their advisor to ensure the completion of this requirement.

For this agreement, PSYC 234 will be utilized as a substitute for COUN 240.

^Students completing MAT 210 (STAT 211 WVU) will meet the prerequisite requirement for PSYC 203 per this agreement.

**Students who complete both PSY 283 and PSY 294 will earn the equivalent of COUN 440.


