Students are required to complete four (4) Lower-Level Electives (LLME). For this agreement, the following will count:

- PHL 1430 = BUSA 1TC or PHL 1150 = BTEC 1TC
- BAD 2070 or BAD 2130 or BAD 2140 = BTEC 2TC
- ECN 2025 = ECON 202

Students transferring into the Bachelor of Applied Science (B.A.S) program can anticipate completing additional required lower-level A.A.S courses during their B.A.S degree pursuits. Students can substitute online upper-level elective courses to complete those lower-level requirements.


Students transferring to West Virginia University with an Associate of Arts or Associate of Science degree will have satisfied the General Education Foundation requirements at WVU.
