For this agreement ATEC 115 (CS 1TC) will substitute for the required CS 101 requirement.

Although not directly equivalent, ACCT 215 and ACCT 216 will be accepted and fulfilled Financial and Managerial Accounting.

Students are required to complete three (3) Lower-Level Electives (LLME). For this agreement, the following will count:

- MRKT 205 = BTEC 104
- MGMT 202 = BTEC 101
- BUSN 201 = BTEC 212

Students transferring to West Virginia University with an Associate of Arts, Associate of Science degree, or Associate of Applied Science will have satisfied the General Education Foundation requirements at WVU.
