Students can select from two different Areas of Emphasis:

- Regenerative Agriculture (16-cr hours)
- Horticulture Production (15-cr hours)

\*AGRN 451 Principles of Weed Science is offered Fall semester of odd-numbered years. ENTO 450 Insect Ecology is offered Fall semester of odd-numbered years.
