\*\*Although not directly equivalent, the following will be accepted to fulfill requirements for this agreement.

- CSCI 1101 (CS 1TC) will satisfy BCOR 121
- ACCT 1212 (ACCT 1TC) will satisfy ACCT 202
- ACCT 1211 (ACCT 1TC) will satisfy ACCT 201

Students completing this proposed pathway may choose to major within one of the following John Chambers College of Business and Economics: Accounting; Economics; Entrepreneurship and Innovation; Finance; General Business; Hospitality & Tourism; Human Resource Management; Management Information Systems; Marketing; or Supply Chain Management.

To be admitted to the Chambers College of Business and Economics, students must have an overall GPA of 2.25. Students must also complete the following College of Business and Economics prerequisite courses with a minimum grade of C- or better:

- ACCT 1211 & 1212
- ECON 2200 & 2201
- ENGL 1100 & 2367
- MATH 1130 or 1146
- CSCI 1101
- STAT 1350

The following majors require ACCT 1212 (ACCT 202):

- Accounting
- Finance

Students need to complete only MATH 1130 (MATH 124) or MATH 1146 (MATH 126) for some majors in the Chambers College of Business and Economics. Students will need to complete MATH 1131 (MATH 150) with a C- or higher only if pursuing one of these majors: Economics, Finance, Supply Chain Management, and Management Information Systems.

Depending upon the student's choice of major, additional criteria for admissions must also be met:

- Accounting: A grade of B- or higher in ACCT 1211 & ACCT 1212; minimum grade of C- in MATH 1130 or MATH 1146.
- Economics: One B- or higher, and one C- or higher in ECON 2200 and ECON 2201; A minimum grade of C- in MATH 1131.
- Entrepreneurship and Innovation: minimum grade of C- in MATH 1130 or 1146 or a D- in MATH 1131
- Finance: A grade of B- or higher in ECON 2200 and ECON 2201; A minimum grade of C- in MATH 1131.
- General Business: minimum grade of C- in MATH 1130 or MATH 1146 or a D- in MATH 1131.
- Hospitality & Tourism: minimum grade of C- in MATH 1130 or 1146 or a D- in MATH 1131.
- Human Resource Management: minimum grade of C- in MATH 1130 or 1146 or a D- in MATH 1131.
- Management Information System: minimum grade of C- in MATH 1131
- Marketing: minimum grade of C- in MATH 1130 or 1146 or a D- in MATH 1131
- Supply Chain Management: A minimum grade of C- in MATH 1131.

Students transferring to West Virginia University with an Associate of Arts or Associate of Science degree will have satisfied the General Education Foundation requirements at WVU.
