Students transferring to West Virginia University under this articulation agreement will be accepted into the Criminology program if they have a C- or higher in SOC 101 (WVU SOC 101).

Unlike the other articulated plan of study to the WVU Criminology major, which are Associate of Arts degrees, this is an Associate of Applied Science (A.A.S). A.A.S. degrees do not satisfy the General Education Foundation requirements at WVU.

Therefore, as indicated in the final two years curriculum, students should work with their advisor to ensure the completion of this requirement. See [catalog](#)
