For this agreement, the following substitutions are approved for the HIIM requirements:

- BIO 1040 & BIO 1040L is equivalent to BIOL 235 & BIOL 236. It will be substituted for PALM 205 & 206
- *Students need to complete all the following: HIM 1103, HIM 1130, and HIM 2100. This will will earn credit for HIIM 112 (HIM 1103), HIIM 242 + HIIM 2TC (HIM 1130) and HIIM 231(HIM 2100 + HIIM 2TC) totaling 10-credits.
- **Students need credit for both BIO 2800 & HEA 1440 to earn credit for HIIM 233
- HIIM 110 requirement will be waived.

A grade of C- or higher must be earned in all graded courses required for the major.

Students transferring to West Virginia University with an Associate of Arts or Associate of Science degree will have satisfied the General Education Foundation requirements at WVU. However, as this is an AAS degree it will not fulfill the requirements. Students will need to work with their faculty advisor to complete all outstanding General Education course prior to graduation.
