Although not directly equivalent students who complete ACC 121 and ACC 240 will have satisfied the Financial and Managerial Accounting course requirements.

\*Pending course offering and student's math placement, students should consider taking MTH 230 (WVU MATH 155) during their time at Eastern. Otherwise, students will need to complete the Math requirement (MATH 150) prior to their first fall at WVU. Students could take the additional Math course in place of MKT 260 or MGT 250 as "concentration elective," as they will transfer in as "general elective" courses.

To be admitted to the John Chambers College of Business and Economics, students must have an overall GPA of 2.25. Students must also complete the following Chambers College of Business and Economics prerequisite courses with a minimum grade of C- or better:

- ACC 121 & ACC 240
- ECN 201 & ECN 202
- ENG 101 & ENG 102
- CIS 114
- MTH 225 & MTH 230 (WVU 155) or MATH 150 (WVU)

Students completing the above articulated plan of study may choose to enroll in any of the following Chambers College of Business & Economics programs: Accounting; Economics; Entrepreneurship & Innovation; Finance; General Business; Global Supply Chain Management; Management; Management Information Systems; Marketing; Organizational Leadership.

The following majors require ACC 240 (ACCT 202):

- Accounting
- Finance
- Global Supply Chain Management
- Management

Depending upon the student's choice of major, additional criteria for admissions must also be met:

- Accounting: A grade of B- or higher in ACC 121 & ACC 240; A minimum grade of C- in MATH 150 or a D- in MTH 230.
- Economics: One B- or higher, and one C- or higher in ECN 201 and ECN 202; A minimum grade of B- in MATH 150. A grade of C- in MTH 230.
- Finance: A grade of B- or higher in ECN 201 & 202; A minimum grade of B- in MATH 150. A grade of C- in MTH 230.
- General Business: minimum grade of D- in MATH 150 or MTH 230.
- Global Supply Chain Management: A minimum grade of B- in MATH 150. A grade of C- in MTH 230.
- Hospitality & Tourism: minimum grade of D- in MATH 150 or MTH 230.
- Entrepreneurship & Innovation: minimum grade of D- in MATH 150 or MTH 230.
- Management: minimum grade of C- in MATH 150. A grade of D- in MTH 230.
- Management Information System: minimum grade of B- in MATH 150 or C- in MTH 230.
- Marketing: minimum grade of C- in MATH 150. A grade of D- in MTH 230.
- Organizational Leadership: minimum grade of C- in MATH 150. A grade of D- in MTH 230.

Students transferring to West Virginia University with an Associate of Arts or Associate of Science degree will have satisfied the General Education Foundation requirements at WVU.
