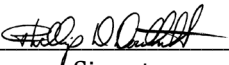
Students will satisfy the four required Lower-Level Major Elective with the following:

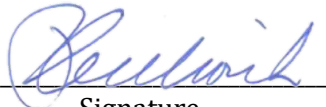
- BUSN 201 = BTEC 101
