Forest Resources Management major requires students to choose from one of three Areas of Emphasis (AOE): Forest Management, Arboriculture & Urban Forestry, or Forest Ecosystem Science and Sustainability. Students need to choose an AOE prior to registering for Year Three, 1st semester courses at WVU.
