For this agreement, the following course substitutions are being allowed:

- ECN 2020 = ECON 201 – ARE 150
- ACC 2020 = ACCT 2TC – ARE 110
- MTH 1015 = STAT 211 – STAT 111

ACC 2340 (WVU’s ACCT 2TC) and MTH 1560 (WVU’s MATH 150) or MTH 1200 (WVU’s MATH 155) has been approved to be utilized as a Restricted Elective.

ARE 491’s summer internship is one of three options available to complete the Agribusiness Management Capstone requirement. Although it is the most pursued option, students may forgo this summer session and complete the requirement via study abroad or thesis composition. Students are encouraged to work with their advisor to select the option that best suits their academic needs and interests.
